# MUDP Programme





#### **Purpose**

The Environmental Technology Development and Demonstration Programme (MUDP) supports companies that contribute to the development of future environmental technology solutions. Grants can be provided for projects and activities related to:

- · Feasibility studies
- Technology development
- · Testing and demonstration
- Establishment and demonstration of fullscale plants
- Environmental technology verification (ETV)


In 2025, the MUDP has a budget of DKK 135 million, distributed as follows:

- DKK 8 million for pre- and ETV-projects
- DKK 63.5 million for development and demonstration projects
- DKK 63.5 million for lighthouse projects, i.e. full scale demonstration of environmental technology solution

#### **Who Can Apply**

- · Private and public companies
- · Private and public research institutions
- Independent institutions
- · Industry organisations
- Associations and groups of the abovementioned actors
- · Private individuals

International project participants without a Danish CVR number, but with another national identification number, can apply for support. Grants can be provided to projects that are implemented in both Denmark or abroad. Additional conditions apply to projects that are implemented abroad.



#### **Environmental priorities in 2025**

MUDP supports projects on a TRL level of 4-8 that contribute to solving environmental challenges within:

- · Circular economy
- · Environmentally hazardous substances
- · Groundwater and drinking water
- Wastewater
- Aquaculture, environmental considerations and climate adaptation
- · Air and noise
- Nature

#### **Deadlines**

- Pre- and ETV-projects\*: Usually in April
- Development and demonstration projects: Usually in May
- Lighthouse projects: Usually in August Deadlines are announced around December each year.
- \* Pre-projects (low TRL) and ETV projects (high TRL) are under de minimis regulation (large enterprises cannot get funded for these projects).

#### **Funding Rate**

The funding rate is determined by factors such as organisation type and activity type. Thus the funding rates are indicative:

- · Small enterprises: between 45 and 70%
- Medium enterprises: between 35% and 60%
- · Large enterprises: between 25% and 50%

#### Selection criteria

When the MUDP board selects projects for funding, the following criteria form the basis for the assessment:

- · Environmental and resource potential
- · Commercialisation and business potential
- The project's novelty value, incentive effect and professional quality
- · The quality of the project description

- Latest annual accounts
- If necessary, powers of attorney to submit an application on behalf of co-applicants; and power of attorney if a third party applies on behalf of a project
